Minutes of the 54th Annual General Meeting of Canterbury Branch of the Model A Club held at the Elmwood Tavern, 14th July 2019.

The meeting was chaired by the Club Captain with twenty two members present.

The chairman welcomed the attendees, called for apologies, and explained the role of proxies appointed by those unable to attend.

Apologies & Proxies:- Wes and Beverly Hartley (N) Brent and Lyn Miles (Chair) John and Sandra Olliver (N) Garth and Pauline Moore (A Hill) Barrie and Barbara Shipley (Chair) Kevin and Judy Straw (A Wills) David and Pam Dacombe (Chair) Martin Rooney (N)

Moved that: "The Apologies and Proxy votes as recorded be accepted and approved."

Previous Minutes – Sent to everyone prior to the meeting –

Moved that: "The minutes of the 53rd Annual General Meeting as presented are a true and accurate record of that meeting."

Moved: A Painter, Seconded: P Bayler. Carried

Matters Arising:

- 1. Federation of Motor Vehicles: Joined as proposed at last AGM. They provided us with updates on any of their lobbying activities. With the push for low or non-pollutant vehicles the pressure will go on to those of us using our type of vehicles so it was a prudent decision to join this association. It costs the Club \$20 plus 50c/member (98) \$49 = \$69
- 2. Club Car disposal/retention SGM completed as per AGM motion with decision clearly in favour of retaining the Club Car.
- 3. Hosting 2023 National Meet. We have been approved to hold this and it will be covered further in General Business .

Correspondence: MAFCA Bylaws, George Spriggs re Car garaging, Federation of Motoring

Club Accounts: Accounts show an excess of income over expenditure of \$420 for the year due to Barrie's prudent management. As both Barrie and Garth were unable to attend the meeting the Chair offered to try and answer any questions but noted that as they had passed Garth's scrutiny, he was more than confident that all was in order.

Moved that "The Treasurer's report as presented and audited be accepted".

Moved G Scott (Chair), Seconded P. Bayler.

The Chair noted that what was not shown was that our cashflow during the period from the end of the financial year until the new subs come in gets tight so it was Barrie's recommendation that the sub level remained unchanged.

Election of Honorary Auditor

Garth had generously agreed to continue to perform this function if it was the wish of the meeting. There were no other volunteers and it was moved that

"Garth Moore be reappointed as Honorary Auditor"

In recognition that Garth had done this for us gratis for a number of years the Chair suggested that some form of recognition be approved for his ongoing efforts on our behalf. He noted by comparison that the VCC (Canterbury) list their 'Independent Review & Accounting' costs as in excess of \$2k and the National VCC as more than 5k so we were very fortunate that Garth does this for us for free. He suggested a \$150 voucher for wine & food. Discussion followed ranging from no physical compensation as many club members have done a lot for the club in the past without compensation to explanation of the costs if a professional was employed. The debate resulted in the following motion being moved.

"That Garth Moore be thanked for his services and given a bottle of wine".

Club Captain's Report: The Club Captain stated he wished to thank the long-standing members for their advice and assistance when approached for historical guidance. He indicated he was keen to get both the club's documentation and history updated as soon as possible. Requests for old copies of the 'Script' and also for photos from past events for inclusion in the Club's photo album would ensure our history is documented. He expressed a need to also get our history documented but so far had not been able to get a volunteer to oversee this function.

Moved that "Club Captains Report be accepted as presented."

Club Car Report. Graham Evans acknowledged George Sprigg's offer of free storage for the Club Car, however the committee voted to reimburse George at the same rate as had previously been paid of \$500 p.a. (well below market rate). George has also provided many free spares for the car.

He also acknowledged Alan Hill's provision of a replacement water pump for just the cost of parts, and also Wes Hartley (Australia) who used the car for the National Rally and noticed that some of the tyres were approaching their used by date and offered to donate to the Club half the cost of replacement tyres. The committee are currently evaluating those costs and the affected tyres will be replaced shortly.

The Chair then advised the meeting that at the May committee meeting the level of 'donation' for use of the Club car was discussed as the existing amount of \$10/day did not cover the costs of any usage repair (as demonstrated when the car had a puncture on the way back from the Nationals). The new rate proposed was \$50/day, \$40 for weddings or similar occasions and \$50 for extended meets such as the Nationals. Given the significant increase, an indication from the meeting was sought of this increase level of suggested donations, balanced against deterring members from using it.

After discussion it was moved "That the suggested level of donations for use of the Club Car should be \$30/day for club runs, \$50/day for longer events such as Nationals and \$100/day for weddings and other private events".

Subscription levels for 2019/2020

Before setting the sub level for the coming year the Club Captain wished to discuss the current system of having a flat rate for all membership categories. Historically there were different rates for each class of membership but at the 2015 AGM all classes of membership were covered by a standard rate of \$40 that encompassed the previous Chapter, Joint and Family members. Whilst preparing the voting papers for last year's SGM having one sub covering all types of membership demonstrated some inequities as well as having no definitive record of each class of membership. Due to this situation the Club Captain would like the meeting's thoughts on whether we keep the flat sub rate to cover all types of membership or whether we revert to a differential rate between Chapter/Full, Joint and Family along the rate of a nominal rate of say a chapter rate, \$2 for Joint and \$1 for a family (non- adult) member (the Family member could include grandchildren). The issue of eligibility for Club trophies and voting and serving on committees are all subject to membership financial status. The Treasurer had advised that in his opinion the annual Subs were about right, however conceded that it may be helpful to return to categories of membership again with the Chapter sub being \$38, plus \$2.00 for joint membership and a further \$1.00 for family membership.

After some debate it was moved that:

"The subscription level for the 2019/2020 financial year be set at \$38 for Full and Chapter membership, \$2 for Joint membership and \$1 for Family membership."

Meeting Closed at 12.33. Presentation of cups and awards by Alan Wills and lunch followed.

Distributor Timing.

The amount of backlash in the distributor will depend on the amount of wear in the ends of the intermediate distributor shaft, distributor and oil pump drive gear and the amount of wear on the center camshaft gear teeth. In many cases the backlash will be one half inch or more. You will not obtain good distributor timing if the parts mentioned above have excessive wear.

The timing can be adjusted to move the backlash to the counterclockwise side so that it doesn't affect the timing. For a quick and fairly easy fix. First set the points at .022", then remove the sparkplugs to remove compression resistance. Remove and reverse the timing pin. Turn the engine over with the hand crank until the timing pin falls into the indentation on the cam gear. Loosen the screw that holds the points cam and adjust the points so that the trailing edge of the rotor tip points at the number one contact in the distributor cap body with NO clockwise backlash. It will probably take a few tries to get the cam tightened so that it points correctly after tightening. In other words, all backlash will need to be in the counter clockwise direction after tightening of the cam so as not to affect the timing. That is really all that there is to it. If you set the timing exactly the way that I describe you should, unless you have other problems, then have good power and throttle response.

The car should then run well at speed with the spark fully advanced and you can retard the spark as necessary for low speed and to control timing knock if under strain. With this method you don't need to be concerned with the time of points opening or the position of the spark lever. Unless the points cam was incorrectly manufactured the points will be opening at the correct time, if you followed the instructions. While the spark plugs are out you may as well clean and set the gap at .035. Polish the plug wire straps with some steel wool or such to improve conduction.

The distributor turns counterclockwise when the engine is running. As the engine turns you should be able to see this with the distributor cap off. The brass tip of the rotor is probably 1/2 inch wide. The trailing edge of this brass tip, as the engine turns, needs to align with the number one contact in the distributor cap body. When the screw that holds the distributor cam to the distributor shaft is tightened, there needs to be NO clockwise backlash or rotation. In other words when the timing is set the TRAILING edge of the rotor tip should point at the number one contact in the cap body with NO clockwise backlash or rotation. If you adjust your distributor timing as explained, you will be amazed at how good your car will run.


